INSTRUCTION / RULES /GUIDELINES

In exchange for the acceptance of said child's candidacy by, I assume all risk and hazards incidental to the conduct of the activities, and release, absolve and hold harmless and all its respective officers, agents, and representatives from any and all liability for injuries to said child arising out of travelling to, participating in, or returning from selected camp sessions. In case of injury to said child, I hereby waive all claims against including all coaches and affiliates, department, all participants, DCB and lessors of premisses used to conduct the event. There is a risk of being injured that is inherent in all sports activities etc..

NOTE: SPECIAL INSTRUCTION:

- **Chief Executive Officer, Delhi Cantonment Board reserve the right to cancel the registration / candidature without giving any notice against the any kind of misconduct or unlawful event.**
- **Pickup and drop facilities of the camper/child will be sole responsibility of parent / guardian.**
- **No fee will charged by the Students of Cantonment Board Schools**
- **Sports Gear- Non marking shoes allowed for badminton court (Coloured soled shoes are not permitted) Own rackets and shuttle cocks etc. are to be brought by the campers.**
- **The management will not be responsible for loss/theft of any personal belongings, either in the indoor badminton stadium, or within the complex.**

Assumption of Risk: Delhi Cantonment Board will provide the basic first aid facility to the camper, in any serious / major injury Camper and I (guardian) are aware that the Activity involves inherent risks, dangers, and hazards that can result in serious personal injury or death. Camper and I are also aware that the DCB facilities and/or equipment contain dangers and can cause serious injury or death Camper and I hereby freely agree to assume and accept all known and unknown risks of injury arising out of the Activity, including injury or death that results.

Release and Indemnity: In exchange for the DCB allowing camper to participate in the Activity. Camper and I, on our own behalf and on behalf of our respective family members, heirs, beneficiaries, assigns and all parties claiming by, through or under either or both of us, do hereby RELEASE, INDEMNITY AND HOLD HARMLESS THE DCB, as well as all of their respective officers/officials from all liability for any injury, death illness (including but not limited to COVID-19), loss or damage connected in any way whatsoever to participation in the activity, including that which may result, directly or indirectly, in whole or in part, from the negligence of the DCB, the negligence or wilful misconduct of any third party, or from the design of the facility and/or equipment.

Medical: Camper and I give consent to emergency medical care and transportation I order to obtain treatment in the event of injury, as the DCB may deem appropriate, and I agree to accept full responsibility for the payment of all costs for same. The release indemnity and hold harmless provisions set forth hereinabove extend to any damage or loss arising out of the medical treatment and transportation provided in the event of an emergency.

Property Loss: all personal property brought to the Activity is brought at the sole risk the Camper as to its theft, damage or loss.

Photograph Permission: I give permission for the DCB to use, without limitation or obligation, photographs, film footage or tape recordings that

may include Camper's image or voice for purposes of promoting the DCB programs.

Severability: Any provision or portion of this Agreement found to be invalid by the courts having jurisdiction shall be invalid only with respect to such provision or portion. The remaining provisions or portion hereof, shall be construed and enforced to the same effect as if such offending provision or portion thereof had not been contained herein.

Health Statement: Neither Camper nor anyone in Camper's immediate family has suffered from or, to my knowledge, been exposed to COVID-19 within the past 15 days. Neither Camper nor anyone in Camper's immediate family has experienced any of the following symptoms in the past seven days nor have they been on medication to alleviate any such symptoms in the past seven days: cough, sore throat, fever, shortness of breath, loss of smell and loss of taste. In the event Camper or anyone in Camper's immediate family experiences any of the foregoing symptoms, I will notify the DCB immediately and will not bring Camper back to the summer camp.

I have authority to enter into this Agreement on behalf of the above-referenced Camper and do hereby execute this Agreement on behalf of myself and Camper.
